EXHIBITOR AGREEMENT

I understand that I assume all risks for loss, theft, damage, liability, injury, cost or expense that I may incur during the 2018 SLO Jazz Festival, and further agree that I will save, defend, and hold harmless SLO Jazz Festival, Inc., and the City of San Luis Obispo and their directors, officials, volunteers, employees, and agents from any claims, loss, liability, damage, or cause of action, including attorneys' fees, that I may incur, suffer, or be required to pay in the course of my participation as an exhibitor in the Festival. I further assume full responsibility for the safety and insurance of my own exhibit, for all sales tax occasioned by its use, and for picking up any and all trash in the area assigned to me, including both festival grounds and/or any parking facility.

I further understand and agree to the following rules (place check/read each rule:

- To conspicuously display a copy of my seller's permit at my exhibit space (if I am not offering for a sale anything that is subject to sales tax, I will provide the Festival with a written statement to that effect, along with my driver's license number.)
- To only exhibit products or services suitable for a family-oriented event
- To park in the designated parking area assigned to me and to conform to all entry and exit traffic patterns during all event days.
- To NOT allow PETS, audio equipment, or alcoholic beverages within or around my assigned space.
- To not exceed my assigned space size.
- To display fire permit and maintain an operational fire conditioner (food booth only).
- To keep my booth operational and set-up **until SLO Jazz Festival Vendor Coordinator approves tear down.**
- To not infringe on walkways, neighboring spaces, or move to another location without official permission.
